The Promise and Peril of Linking Cooperation on Trade to Cooperation on Climate Change

Scott Barrett is a leading scholar on transnational and global challenges, ranging from climate change to disease eradication. His research focuses on how institutions like customary law and treaties can be used to promote international cooperation.

He has advised a number of international organizations, including the United Nations, the World Bank, the OECD, the European Commission, and the International Task Force on Global Public Goods. He was previously a lead author of the Intergovernmental Panel on Climate Change and a member of the Academic Panel to the Department of Environment in the UK.

Barrett has been awarded the Resources for the Future Dissertation Prize, the Erik Kempe Prize by the European Association of Environmental & Resource Economists, the Publication of Enduring Quality Award by the Association of Environmental & Resource Economists (AERE), and the degree of Doctor of Laws, *honoris causa*, by the University of Bath. In 2019 he was made an AERE Fellow. He is the author of numerous journal articles and two books, *Environment and Statecraft: The Strategy of Environmental Treaty-Making* and *Why Cooperate? The Incentive to Supply Global Public Goods*, both published by Oxford University Press.
